1. The candidates intending to appear in the B.A./B.Sc./B.Com. 6th semester examinations, 2020 in **ONLINE** mode need to register themselves in the Online Registration Portal being activated **today** in the University website www.dibru.ac.in. The last date of Registration for the online examination is **30.09.2020 (till 11:59 PM)**.
2. The candidates once registered to appear the examinations in online mode **shall not be allowed to shift** to the offline mode or vice-versa under any circumstances.
3. The respective colleges/ institutes shall arrange to **monitor** their own candidates appearing the examination in **ONLINE** mode through **any video conferencing tool** like Google Meet/ Zoom/ Skype/ WebX etc. Further the **meeting id/ link must be shared with the undersigned** at the email id: coe@dibru.ac.in
4. The colleges/ institutes may take necessary steps to **record** the online examination sessions for future reference.
5. The colleges/ institutes shall appoint **invigilators** for both **OFFLINE** as well as **ONLINE** mode of examinations.
